## 2. RECEIVE INFORMATION AND MAKE DECISIONS ON ACTIONS AND EXPENDITURE AS REQUIRED REGARDING THE FOLLOWING ITEMS

### a) Issues created by trees and hedges overgrowing roads and rights of way in the Parish, and remedies for dealing with them.

- Clerk has shared details of the Highways Act 1980 Section 154 with Councillors; this outlines the responsibilities for those who own land from which overgrowing trees and hedges are affecting roads or other public rights of way.
- Cllr. Wickenden reported two locations, affecting a footpath and a highway, which require attention, **CLERK** to report to ESCC.
- Regarding to domestic hedges and tree overhanging pavements it was agreed to accept Cllr. Kember's offer to draft a notice to give to residents concerned and drawing their attention to their responsibility to cut back. It is acknowledged that in some circumstances the home owner may not be in a position to undertake the work themselves. **CLERK** to research if we have a previous document to adapt and add an item to Facebook requesting that parishioners check their hedges.
- If no action is taken the landowner may be reported to East Sussex Highways who are empowered to issue an enforcement notice to the owner and, if necessary, undertake the work and charge cost to the landowner.

### b) Long vehicle issues in the Parish – update regarding further mitigation measures.

Clerk advised that no reports had been received so far in response to the "Your Village Needs You" poster campaign. Response awaited from East Sussex Highways regarding suggestions passed to them from the Parish Council regarding mitigation measures. Once a response is received a meeting will be arranging involving East Sussex Highways Officers, County Councillors, ESCC Lead Member for Highways and our MP.

### c) Arrangements for repainting of cast village nameboards in Rotherfield and Mark Cross.

**RESOLVED** to obtain quote from contractor who maintains our fingerposts to repaint the signs in Mayfield Road and by Highgate flats. Due to location by the A267 it may not be possible for the Mark Cross sign to be dealt with.

### d) Eridge Station. Information regarding the Passenger Benefit Fund and applying for funds for improvements to the station.

Cllr. Harris has submitted the questionnaire relating to this and response is awaited.

### e) Terms of Reference for Working Group investigating Community Match funding for speed awareness measures for Rotherfield.

Draft document circulated prior to meeting. Cllr. Henrick summarised the aspirations for speed awareness and other measures for Rotherfield, also measures which had been considered for Mark Cross. **RESOLVED** that the Terms of Reference be adopted. The Group will consider measures for Rotherfield and Mark Cross and present their recommendations for the match funding application at the September Council meeting so that the ESCC submission deadline of October 31<sup>st</sup> can be met, **CLERK** to note. Cllrs. who wish to be part of the group please contact Cllr. Henrick.

### f) 2019 Christmas lights arrangements.

**CLERK** to check with Bonfire Society and Contractors regarding arrangements and date for "Switch on". Cllr. Harris is to be the Rotherfield contact for the illuminations and Cllr. Kitchenham the contact for Mark Cross.

**4. REPORT DETAILS OF ITEMS AND ISSUES FOR INVESTIGATION, FURTHER ACTION OR FOR FUTURE AGENDA.**

- Cllr. Kember raised concerns regarding the number of vehicles parking on Village pavements. **CLERK** is to arrange for a further supply of parking “calling cards” to be printed for Councillors to deploy on offending vehicles should they wish.
- Cllr. Martin has met with contractors installing the new pavement at Mark Cross who intend starting work as soon as the School have broken up for the Summer. He also suggested that the grit bins all be replenished as it would then show how much grit remained in store; thought may be given to finding an alternative site for this store, space for which is currently provided through the kindness of a Village business.
- **CLERK** to investigate when the white lining work in the car park by the Village Hall is to be repainted and report to Cllr. Watson-Smith.
- Cllr. Wickenden requested that an item be added to the agenda of this Committee’s next meeting to revisit the Village – Jarvis Brook path project which is currently dormant. **CLERK** to note.
- **CLERK** to raise report with East Sussex Rights of Way regarding tree and stile issues on Fp44 at Mark Cross. Clerk also reported that two incidents of fly tipping had recently occurred in the Parish, in Palesgate Lane near Jarvis Brook Football Club, and in Castle Hill near Trebler’s Road junction. Both had been reported to the Wealden Streetscene Team; the first incident has been dealt with and the site cleared, the second” tip” contained full contact details of the waste “owner” which WDC are following up, hopefully resulting in action being taken against both them and depositor of the waste.
