**2. TO CONSIDER AND MAKE RECOMMENDATIONS ON THE FOLLOWING APPLICATIONS AND OTHER PLANNING MATTERS**

**a) WD/807/CM Laurel Tree Farm, Boars Head Road, Boars Head Road, Boars Head, TN6 3 Town and Country planning (Development Management Procedure) (England) Order 2015- re-Grading of land known as Home, Old Hop and Banty.**

The members of the public had the opportunity to give their views on this application. They expressed concerns that the site has been in use for 20 years with associated noise unauthorised burning of materials and felling of trees. The current pit could go on much longer as it may have 50% more capacity before it is completely full.

The Committee **RESOLVED** to recommend to the Wealden District Council Planning Officer that this application be **REFUSED**.

**REASON.** Negative impact that this development will have on this area of outstanding natural beauty and its proximity will have a detrimental effect towards the air quality of the Ashdown Forest and the surrounding area.

**b) WD/2018/1975/LB 1 Hamsell Manor Cottages, Sham Farm Road, Eridge Green, Tunbridge Wells, TN3 9JB replacement of top layer (water reed) with heather to existing thatched roof of outbuilding (dairy house)**
