2. TO CONSIDER AND MAKE RECOMMENDATIONS ON THE FOLLOWING APPLICATIONS AND OTHER PLANNING MATTERS.

a) WD/2017/1653/FA Little Acre, Tunbridge Wells Road, Mark Cross, TN6 3PR Removal of condition 3 of WD/1995/9002/ENF (One residential caravan for occupation by gypsy family and installation of cesspool).

The applicants were present and, together with a relative, gave background to issues arising from the purchase and the history of the site.

The Committee **RESOLVED** to recommend to Wealden District Council planners that this application be **APPROVED**.

REASON: - It will regularise the planning position for this site.

Cllr. Martin wished it noted that, by removing the condition relating to occupation by a gypsy family it would be necessary for Wealden DC to allocate a replacement site elsewhere in the district.

- Wealden District Council have advised that we will be receiving a Community Infrastructure Levy payment of £506.58 within the next few days. Clerk has requested information as to which development this relates to.
- East Sussex Highways confirm that the white lining work opposite the Church and in the Millennium Green car park at Mark Cross will be taking place on 23rd October, or at some point during that week if weather conditions dictate. Clerk has advised local users of this and requested they do not use the areas on that day. Cllr. Martin recommends that we "cone" the areas involved beforehand and that a supply of these be obtained for this and future uses. Clerk confirmed that the expenditure of approximately £200 involved falls within delegated limits in section 4.1 of Financial Regulations, and Cllr. Martin will obtain 20 cones of the triangular yellow "no waiting" variety.
- Clerk advised that the "day burning" streetlight at the top of Catt's Hill near the Mark Cross junction has been reported to East Sussex Highways.

The Chair declared the formal business of the meeting closed at 20:15.
