**b) Review combined Parish Council total budget.**

**c) Agree Precept for 2019/20 to be considered for final agreement by the Full Council.**

Clerk reported that, due to the date of this meeting being brought forward, the “Tax Base” figures had yet to be received from Wealden to enable the Precept for 2019/20 to be expressed on a “£s per “Band D” property” basis and allow comparison to the 2018/19 figures. Information is anticipated by end of week.

**ii. Review Committee’s Terms of Reference and the Council’s Financial Regulations.**

**a) RESOLVED** that **CLERK** to amend and update these following recommendations in the recent Internal Audit Report and add an item to the agenda of the January Council Meeting to consider approval. **CLERK** to also review progress with the review of the Council’s Policies and other governance documents for inclusion on the same agenda.

**b) Recent Audit Report identified the following:-**

- The Council’s income is reaching the stage at which the DCLG’s Local Government Transparency Code 2015 will apply – “Parish Council’s with gross annual income or expenditure exceeding £200000 must disclose additional information”.

**CLERK** to investigate/report/action what is required to meet the Code’s requirements.

- This Report also identified that the requirements of the “Governance and Accountability for Smaller Authorities in England 2017 Edition” require that authorities where the gross income or expenditure for the year (whichever is the higher) has exceeded the threshold of £200,000 for a period of three continuous years, to report their financial details on an income and expenditure basis, from the
